

**ROAD TRAFFIC REGULATION ACT 1984**  
**LANCASHIRE COUNTY COUNCIL**  
**(VARIOUS LOCATIONS, WEST LANCASHIRE BOROUGH) (REVOCATION OF**  
**RESTRICTED ROADS) ORDER 2026**

The County Council of Lancashire, in exercise of its powers under Sections 82(2) and 83(2) of and Part IV of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

**1. Revocation**

- a) "The Lancashire County Council (Restricted Roads) (No.2) Order 1981" is hereby revoked in full.
- b) "The Lancashire County Council (Course Lane A5209, Newburgh, West Lancashire District) (Restricted Road) Order 1994" is hereby revoked in full.
- c) "The Lancashire County Council (Higher Lane C161, Dalton, West Lancashire District) (Restricted Road) Order 1994" is hereby revoked in full.
- d) Those parts of the "Lancashire County Council (Various Road Including A570 and A577, Burscough, Blaguegate, Ormskirk, Skelmersdale and Westhead, West Lancashire) (Revocation, Restricted Road, De-Restriction, 40mph and 50mph Speed Limits) Order 2015", as set out in Schedule 1a to this Order, are hereby revoked.
- e) Those parts of the "Lancashire County Council (Various Roads, West Lancashire Borough) (Part Revocation, Restricted Road 30mph, 30mph and 40mph Speed Limit Order) 2017", as set out in Schedule 1b to this Order, are hereby revoked.
- f) Those parts of "The County Council of Lancaster (Restricted Roads) (No.6) Order 1971", as set out in Schedule 1c to this Order, are hereby revoked.
- g) Those parts of "The Lancashire County Council Moss Lane (Also Known As Straight Up Lane) and Wyke Lane, North Meols, West Lancashire District – Restricted Roads Order, 1997", as set out in Schedule 1d to this Order, are hereby revoked.
- h) That part of the "Lancashire County Council (Blaguegate Lane, Skelmersdale and Crosshall Brow, Ormskirk, West Lancashire Borough) (Revocation, Restricted Road and 40mph Speed Limit) Order 2013" as set out in Schedule 1e to this Order, is hereby revoked.
- i) That part of the "Lancashire County Council (Cobbs Brow Lane, Cobbs Clough Road and Whalleys Road, Skelmersdale, West Lancashire Borough) (Restricted Road, 30mph and 40mph Speed Limit) Order 2013" as set out in Schedule 1f to this Order, is hereby revoked.
- j) That part of the "Lancashire County Council (Higher Lane, Beacon Lane and Hillock Lane, Dalton, West Lancashire Borough) (Restricted Road and 40mph Speed Limit) Order 2012" as set out in Schedule 1g to this Order, is hereby revoked.
- k) That part of the "Lancashire County Council (Various Roads, Bickerstaffe, Down Holland, Halsall, Scarisbrick, Aughton and Hesketh Bank, West Lancashire Borough) (Revocation, Restricted Road, 30, 40, 50 and 60mph Speed Limit) Order 2012" as set out in Schedule 1h to this Order, is hereby revoked.

## **2. Commencement of Order**

This Order may be cited as the “Lancashire County Council (Various Locations, West Lancashire Borough) (Revocation Of Restricted Roads) Order 2026” and shall come into force on the 31<sup>st</sup> day of August 2026”.
